Circulation Journal: A Cloud Over the Hill

Circulation Journal, the official journal of the Japanese Circulation Society, is on the way to becoming one of the major scientific journals in cardiovascular medicine and research in the world. As I mentioned in my editorial message in the January 2009 issue, we believe that the Japanese Circulation Society should represent not only Japan, but also other countries in the Asia-Pacific region. This would make the position of the Journal in our region equivalent to that of Circulation, published by the American Heart Association (AHA), in America and European Heart Journal, published by the European Society of Cardiology (ESC), in Europe (Figure). Ryotaro Shiba, a famous Japanese writer, described the situation of Japan and the Japanese people in the Meiji era (more than 100 years ago) as "a cloud over the hill" (saka no ue no kumo in Japanese), signifying a developing country (Japan) aiming at Western countries (USA and European countries). The current situation of our Circulation Journal is also "a cloud over the hill", aiming at Circulation and European Heart Journal (Figure). Our Editorial Team will make every effort to enhance the scientific level and internationalization of Circulation Journal as follows.

1. Internationalization of the Journal

Since last July, 11 international associate editors have joined our Editorial Team, and have already contributed substantially to enhance the scientific level and internationalization of the Journal. I greatly appreciate their valuable contributions to the Journal. We will organize joint Editorial board meetings during the JCS meeting in Japan and the AHA meeting in the USA. In addition, every month, Circulation Journal publishes review articles written by internationally recognized cardiovascular scientists. I also appreciate their valuable contributions to the Journal. Furthermore, in addition to the free online journal system, we have started an international e-mail service that informs more than 5,000 foreign cardiovascular researchers of the contents of the current issue of the Journal every month.

We will continue these awards to commend the authors of papers at the highest scientific levels, as well as reviewers with the highest review performance.
