Submission of a manuscript to *Circulation Reports* implies that, when the manuscript is accepted for publication, the authors agree to automatic transfer of the copyright to the Japanese Circulation Society. Circulation Reports is an open-access journal under Creative Commons Attribution-NonCommercial-NoDerivavatives (CC BY-NC-ND) License (https://creativecommons.org/licenses/by-nc-nd/4.0/). Anyone may download, reuse, copy, reprint, and distribute articles published in the journal for not-for-profit purposes if the original authors and source are properly credited. Remixing, transforming or building upon the material is not allowed, and any modified material is prohibited from distribution. For profit or commercial use, appropriate permission by the Japanese Circulation Society is mandatory. If authors would like to post their accepted manuscript on an online repository of an affiliated institution, they can do so as long as they use the accepted version of their manuscript, downloaded from the journal's online submission system. In such instances, the authors are responsible for indicating the article's citation and the link to the published article on *Circulation Reports'* online journal website (https://www.jstage.jst.go.jp/browse/circrep/-char/en).

Published articles and articles in <u>Online Advanced Publication</u> require permission for secondary use:

- Payment of royalty fees to us (except for CCBY-NC-ND).
- To clearly indicate the source when you publish it.

### **Procedure for Application**

Please fill out the **application form** and send it by fax/e-mail (DO NOT change the format).

Do not leave any blanks (approximate circulation/distribution, publishing date are also required).

Attach a copy of the completed article (JPG/PDF etc.) with highlighted figures/tables that are planned to be used. Also mail a copy to the address below.

Permission is for 1 article = 1 purpose. Permissions are given per manuscript (not to each figure).

Examples of individual permissions being required:

- Exactly the same Powerpoint slides used for several pharmaceutical companies
- Figures anticipated to be used on a website, but also planned to be inserted in a movie file

• Ordering 100 offprints and translating/distributing another 100 offprints in another language.

We require payment of the following amounts as royalty fees. Please indicate whether or not you wish to continue the process (NO cancellations are accepted once the procedure has started).

\*It is strongly recommended to send a copy of the receipt or other evidence by fax or email to show payment.

If you order offprints, please submit the secondary use permission form at the same time.

# **Frequently Asked Questions**

### Q. Is there an expiry date for permissions?

A. No. Once permission is given, it will be valid for the intended purpose.

#### Q. We would like to use only part of a table or 2 figures combined as 1.

A. Permitted as long as sources are clearly indicated (however, guidelines cannot be changed).

Q. Our website is members only, with less than 1,000 users. Do we only need to pay JPY 300,000?

A. No, JPY 500,000 is required, because it is to be used on a website.

#### Q. How much exactly must be paid for secondary use?

A. If it is for commercial purpose:

1) 1,000 offprints: JPY 300,000 + offprint printing fee + shipping fee

2) Website member-only with less than 1,000 users: JPY 500,000.

# Q. Can we order offprints with company name/company logo on the back cover?

A. Please contact us about individual cases (however, advertisements are not accepted).

# Q. Do we need permission for Supplementary Files? Also, are Supplementary Files included in offprints?

A. Yes, permission is required for Supplementary Files. Supplementary Files are usually not included in offprints (an extra charge is made).
