On behalf of the Japanese Circulation Society (JCS), I would like to let you know about the close partnership agreement between the JCS and the European Society of Cardiology (ESC) and the top 35 papers most frequently quoted in the 2010 issues of the *Circulation Journal*.

1. Close Partnership Between the JCS and the ESC

During the 2011 ESC Meeting in Paris, the JCS and the ESC had a fruitful meeting, confirming the close partnership between the 2 societies, as in the case with the American Heart Association (AHA) and the American College of Cardiology (ACC). Our agreement includes not only confirmation of the partnership but also active scientific interactions in meetings, memberships, educational activities, and publications by both sides. Indeed, the number of abstracts submitted from Japan for the 2011 ESC meeting was 1,213, a marked increase from the 550 in 2007, making Japan the No. 1 country in the world. Similarly, for the 2011 AHA meeting this year, Japan ranks No. 2 after the USA, with 1,848 abstract submissions. We, the JCS, would like to enhance the close partnerships with the ESC, AHA and ACC.
